

THIS IS THE LAST WILL AND TESTAMENT of me SARAH WEST of Laurel House Broad Oak Heathfield in the County of Sussex Widow I APPOINT my daughters Elsie Sarah West and Ruth Naomi West (Hereinafter called "my Trustees") to be Executrices and Trustees of this my Will I GIVE to my son William Daniel West my Grandfather Clock I GIVE to my daughter Emma Jane West my Mahogany Writing Table and Kitchen Armchair I GIVE to my son Asher West my Marble top Washstand I GIVE to my son Frederick West my Loo Table I GIVE to my son Percy West my Horsehair Sofa and Copper Coal Scuttle I GIVE to my daughter the said Elsie Sarah West my Tea Service given to me on the occasion of my marriage and my Chippendale Armchair I GIVE to my son John Aldworth West an armchair I GIVE to my daughter Mary Westell West my Oak Gateleg Table I GIVE to my son Heber West my High Back Windsor Armchair I GIVE to my daughter the said Ruth Naomi West my Bureau Bookcase and five Maple Photograph Frames containing photographs of various ministers I GIVE my Headless Dragon Tea Service to my four daughters to be divided equally between them during their respective lives and on the death of either daughter the surviving daughters are to take in equal shares the portion belonging to the deceased daughter for their respective lives and so that the last surviving daughter shall have the whole of the said Tea service for her own use absolutely I DECLARE that neither of my said daughters shall be responsible for any loss or breakage which may occur to that portion of the said Tea Service which may be in her possession during her life I DECLARE that any child of mine shall be at liberty to take from the home any piece or pieces of furniture which they may have placed there for my use during my lifetime AND I ALSO DECLARE that the remainder of the furniture shall be divided between all my children and in case of any dispute the decision of my Trustees shall be final I GIVE DEVISE AND BEQUEATH the rest and residue of my estate both real and personal including any property over which I have a power of appointment by will at the time of my decease unto my Trustees Upon Trust to sell call in and convert into money such part or parts as shall not consist of money and after payment thereof of my just debts funeral and testamentary to pay and divide the residue if any then remaining to my four daughters the said Emma Jane West Elsie Sarah West Mary Westell West Ruth Naomi and my two sons the said Heber West and Frederick West in equal shares I AUTHORISE and EMPOWER my Trustees to postpone the sale collection conversion of my estate or any part or parts thereof for such a period or periods as they shall deem expedient without being answerable for any loss which may be occasioned thereby LASTLY I revoke all former Wills and Testamentary dispositions of any kind heretofore by me at any time made IN WITNESS whereof I have hereunto set my hand this *twentieth* day of *April* One thousand nine hundred and twenty five.
